VACANCY CIRCULAR

Sub: Filling up the post of Managing Director (MD) in MP Power Transmission Company Ltd., Jabalpur.

After unbundling of Madhya Pradesh State Electricity Board (MPSEB), separate companies (one Generation, one Transmission, Three Distribution and one Power Management Companies) have been formed by the Government of Madhya Pradesh. These companies have been granted autonomy with effect from 1<sup>st</sup> June 2005. M.P. Power Transmission Company Ltd., Jabalpur is looking after the work of power transmission in the State.

2/ The present Managing Director of MP Power Transmission Co. Ltd. is completing his tenure in April, 2020, therefore, Government of M.P. is seeking a suitable candidate to appoint as the Managing Director of MP Power Transmission Company Ltd. with headquarter at Jabalpur. The MD of the company in his capacity as CEO, will be responsible for overall management of the company with focus on improving performance of the company. The incumbent should have a proven track record and have the initiative, capacity and drive to lead organizational transformation. The responsibilities of the MD include development and implementation of the company's business plan, ensuring improvement in operational and financial performance and managing key stakeholders. The MD shall get a pay scale of Executive Director of the Company (M.P. Power Transmission Co. Ltd.) with similar perquisites, subject to reduction by an amount of pension / pension equivalent as per prevailing rules.

3/ **Eligibility Criteria:-**

(a) The candidate's age should not be more than 60 years at the time of making application and shall be appointed for the duration of not more than three years.

(b) Officers fulfilling above criteria, with experience in Administrative / Technical / Finance or Management functions having worked as Additional Chief Engineer or above in the respective cadre preferably in Power Sector Company. He shall be eligible for reappointment for one more term of period not exceeding 3 years subject to the recommendations of the Selection Committee constituted for the purpose, provided that he has not crossed the age of 60 years at the time of making application for reappointment.

4/ The candidates may submit their applications by post / email at the address given in paragraph 5 below in advance alongwith curriculum vitae and names of two referees. **Last date for receipt of applications is 13<sup>th</sup> April, 2020 .**

The following documents would also be required in respect of applicants :-

- (i) CR grading for past five years
- (ii) Vigilance status and details of major/minor punishment during last 5 years.
