2. Good knowledge of computer applications (on word processor, spreadsheet, presentations software etc. And OS like MS-Windows, LINUX etc.) will be preferred.
3. Applicants serving in Government/Semi-Government Organizations/Public Sector Undertakings/Autonomous Bodies must send their applications "**Through Proper Channel**". The applications received directly (not through proper channel) may not be considered. However, an advance copy of application may be sent followed by the original application through proper channel.
4. The contract may be extended for another one years on satisfactory performance.
5. 7. The institute reserves the right to relax any of the qualifications/experience/age in exceptional cases of meritorious candidates.
8. The number of vacancies indicated in the notification is tentative. The ABV-IIITM Gwalior reserves the right to increase or decrease the number of advertised posts at the time of selection. Further, the ABV-IIITM Gwalior also reserves the right NOT to fill any of the post advertised.
9. Candidates shall have to produce original documents at the time of appearing in Test/Interview.
10. No correspondence whatsoever will be entertained from candidates regarding conduct and result of interview and reasons for not being called for interview.
11. The Institute may conduct Written Test/Skill Test/Computer Test/Power Point Presentation on some topics/ and only those candidates who qualify the said tests may be called for interview.
12. The prescribed essential qualification/Experience indicated are bare minimum and mere possession of same will not entitle the candidates to be called for test/interview. Where number of applications
